Agenda Item No.1: AMC of RO installed at CC1.

One RO Aqua guard Prima 50 B GWPDPREM50B000 serial no. 5023487 of 50 Ltrs capacity is installed at CC-1, the same was donated by Kailash Healthcare under CSR Scheme (Dr. Mahesh Sharma Hon'ble MP Noida). The use of this RO is very high and it runs 24 Hrs. The AMC from OEM was taken in February 2025 which is expiring on February 2026.

2. Proposal/quotation to renew the AMC for one year from OEM which will cover all filters, electrical and electronic items. AMC for one year quote from OEM is for Rs. 17,940/- including 18 per cent GST, which is same as for previous year.
