The President welcomed all Members to the 27th meeting of BOM, KV-II held on 12th May 2025 and requested Secretary to initiate the discussions on the Agenda points circulated earlier. Meeting started with approving the minutes of 26th BOM meeting held on 01.05.2025.

<u>Agenda Item No.1: Ex-Post Facto approval for the Expenditure incurred on 26th January 2025</u> Republic Day Celebrations.

It was noted that approval of Rs 2, 45,000/- was given by BOM in its meeting held on 29.12.2024 for this purpose. The total expenditure on the function related to the republic day celebrations came to BOM went through the data it.
